The background to these changes

- Microsoft Learning content was aligned to products:
 - Implementing Networking on Windows Server 2016
 - Implementing Identity on Windows Server 2016
- Now certifications, and learning content, is aligned to job roles:
 - Administering Office 365
 - Managing modern desktops
- From time to time, changes are required:
 - The user interface changes in something like Azure
 - Microsoft review and adjust the job roles (JTA)
 - The technologies underpinning a job role change



The intent of the updates

- MD-102:
 - Update content with additional material and streamline certification
- MS-102:
 - Update content
 - Combine MS-100 with MS-102
 - Streamline to accommodate additional material



Exam MD-102: Endpoint Administrator



MD-101 plus the following new content:

- Configure Remote Help in Intune
- Configure the Windows Admin Center
- Manage role-based access control for Intune
- Implement the Intune Connector for Active Directory
- Manage the membership of local groups on Windows devices
- Implement and manage Local Administrative Passwords Solution (LAPS) for Azure AD
- Configure policy sets
- Configure and implement profiles on Android devices, including fully managed, dedicated, corporate owned, and work profile
- Plan and implement Microsoft Tunnel for Intune
- Monitor devices by using Azure Monitor

- Manage Android updates by using configuration profiles
- Configure Windows client delivery optimization
- Implement and manage security baselines in Intune
- Onboard devices to Defender for Endpoint
- Implement automated response capabilities in Defender for Endpoint
- Review and respond to device issues identified in the Microsoft Defender Vulnerability Management dashboard
- Configure Microsoft 365 Apps deployment by using the Microsoft Office Deployment Tool or Office Customization Tool
- Configure policies for Office apps with Group Policy or Intune
- Implement Conditional Access policies for app protection



MD-101 plus the following content from MD-100:

- Configure Remote Desktop on a Windows client
- Configure PowerShell remoting and Windows Remote Management
- Implement user authentication on Windows devices



Exam MS-102: Microsoft 365 Administrator



A hybrid of MS-100 and MS-101

From MS-100:

- Implement and manage a Microsoft 365 tenant
- Manage users and groups
- Manage roles in Microsoft 365
- Implement and manage identity synchronization with Azure AD
- Implement and manage authentication
- Implement secure access

From MS-101:

- Manage security reports and alerts by using the Microsoft 365 Defender portal
- Implement and manage email and collaboration protection by using Microsoft Defender for Office 365
- Implement Microsoft Purview information protection and data lifecycle management
- Implement Microsoft Purview DLP



... plus:

- Implement and manage endpoint protection by using Microsoft Defender for Endpoint:
 - Onboard devices to Defender for Endpoint
 - Configure Defender for Endpoint settings
 - Review and respond to endpoint vulnerabilities
 - Review and respond to risks identified in the Microsoft Defender Vulnerability Management dashboard



Gaps left by changes

- MD-102:
 - There's little content on the basic Windows client (in other words, almost no content from MD-100)
- MS-102:
 - Some content from each course necessarily removed, leaving some knowledge gaps
